## **COVID-19 Boosters Are More Important for Older Adults**

Older adults may benefit more from the latest COVID-19 boosters and future updates to the vaccines, recent research suggests.

These individuals are being disproportionately affected by the virus in the U.S. compared with younger citizens, government data shows. To date, the majority of deaths attributed to COVID-19, 75% are of people ages 65 and older, according to data from Centers for Disease Control and Prevention.



A study conducted by a researcher at UT Southwestern Medical Center in Texas, found protection offered by two doses of a COVID-19 vaccine decreases with age and is "suboptimal" for older adults.

"The fact that these antibody functions decrease with age is one reason why the elderly are still more susceptible to severe illness with COVID-19 and highlights the need to develop different approaches for older, vulnerable individuals," Dr. Lenette Lu, Internal Medicine and Immunology at UT Southwestern, said in a statement.

Ultimately, because the study shows receiving two doses of an original vaccine is less effective for older individuals, it "underscores the need for boosters and variant-specific vaccines for older adults," the release states.

## **Stanislaus County Moves from Low to Medium**

As the winter approaches, the spread of COVID-19 has risen to the medium level of transmission in Stanislaus County and has been resulting in more hospital visits than those caused by other respiratory virus.

According to an article in the Modesto Bee written by Ken Carlson; The coronavirus accounted for 1,966 emergency room and inpatient hospital visits in November at hospitals in the county, more than RSV and influenza. It was the highest number since a peak in July. According to the county data, influenza accounted for 1,114 hospital visits, and 1,044 visits were RSV-infected patients.

Kamlesh Kaur, a spokesperson for the county public health division said, "Our cases have increased, people who are sick should stay home and separate from others, so they don't spread infection."

Dr. Thea Papasozomenos, who was appointed Stanislaus County Health Officer, said in an email that wastewater sampling also shows increasing levels of COVID-19 in the Modesto area.

Papasozomenos said the main variant circulating include BA.5, accounting for 23.6% of transmission, and Omicron BA.1 (29.9%). But also include a potentially troubling newcomer, Omicron BQ1.1, now the most prevalent coronavirus strain in California. In the latest state data, the BQ1.1, variant was found in 60% of cases in California.

According to the wastewater sampling, about 30% of transmission in Stanislaus County is BQ1.1.

"While we are seeing a lot of respiratory viruses circulating this season, we also know of ways our community can prevent from getting sick, "Papasozomenos said. "We have vaccines available for both influenza and COVID-19.

COVID activity was also elevated in the latest state data released Thursday, including a new case rate of 13.6 per 100,000 population statewide. California test positivity of 10.8% is double the rate three weeks ago.

Almost 3,800 people hospitalized in the state had COVID-19, including 408 patients in intensive care units, according to the California Department of Public Health

In Stanislaus County **354,808** people **(64.4%)** have received at least one vaccine dose, **302,378** individuals **(54.9%)** have received at least two doses of the vaccine, and **142,621** people **(25.9%)** received a booster shot.

### Where to Get At-Home Test Kits

Testing is important. You may need to test at home or at a local pharmacy who provides tests. Medicare, Medical or private insurance will pay for in-home rapid antigen tests at the pharmacies. However, if you are using private insurance you may have to pay upfront and get reimbursed by your insurance.

Some healthcare providers such as Kaiser Permanente, if you are a member, you can request tests and they will mail to their members.

## **When Should I Test for COVID-19**

#### If you have any symptoms of COVID-19

- Test immediately, regardless of your COVID-19 vaccination status.
- If your test is negative but you continue to have symptoms, test again 24-48 hours later.

#### If you have had close contact with someone with COVID-19,

- Test when notified of exposure and 3-5 days after exposure, even if you have no symptoms.
- Test immediately if symptoms develop.

Consider testing before and 3-5 days after a gathering, a large event or travel, especially if you are going to be around people who are higher risk. (older adults, immunocompromised, unvaccinated people).
